## **Non-Vaccinated COVID-19 Self-Screening Form**

Please complete this self-screening and take your temperature at the beginning of each day before arriving on campus. If you answered “Yes” to any questions please notify the site secretary.

**1. Is your temperature more than 100.4° F?**

**Yes** - Do not return to school until you are fever free for 24 hours without any fever reducing medication and a negative COVID test

**No** – Continue with questions

**2. Are you experiencing any symptoms such as fever, cough, or shortness of breath?**

**Yes** – You should not return to school until you have met the following conditions:

- a. At least 24 hours have passed since resolution of fever without the use of fever-reducing medications; and
- b. Other symptoms have improved; and
- c. You have a negative test for SARS-CoV-2, OR a healthcare provider has provided documentation that the symptoms are typical of their underlying chronic condition (e.g., allergies or asthma) OR a healthcare provider has confirmed an alternative named diagnosis (e.g., Streptococcal pharyngitis, Coxsackie virus), OR at least 10 days have passed since symptom onset.

**No** - Continue with questions

**3. Have you been in close contact\* with anyone who has been diagnosed with COVID-19?**

**Yes – If individuals were masked:** When both parties were wearing a mask in any school setting in which students are supervised by school staff (including indoor or outdoor school settings and school buses, including on buses operated by public and private school systems), unvaccinated students who are close contacts (\*more than 15 minutes over a 24-hour period within 0-6 feet indoors) may undergo a modified quarantine as follows. They may continue to attend school for in-person instruction if they:

- a. Are asymptomatic;
- b. Continue to appropriately mask, as required;
- c. Undergo at least twice weekly testing during the 10-day quarantine; and
- d. Continue to quarantine for all extracurricular activities at school, including sports, and activities within the community setting.

**-OR-**

**Yes– If individuals were unmasked:** Quarantine recommendations for: unvaccinated close contacts who were not wearing masks or for whom the infected individual was not wearing a mask during the indoor exposure:

a. For these contacts, those who remain asymptomatic, meaning they have NOT had any symptoms, may discontinue self-quarantine under the following conditions:

i. Quarantine can end after Day 10 from the date of last exposure without testing;

OR

ii. Quarantine can end after Day 7 if a diagnostic specimen is collected after Day 5 from the date of last exposure and tests negative.

b. To discontinue quarantine before 14 days following last known exposure, asymptomatic close contacts must:

i. Continue daily self-monitoring for symptoms through Day 14 from last known exposure; AND

ii. Follow all recommended non-pharmaceutical interventions (e.g., wearing a mask when around others, hand washing, avoiding crowds) through Day 14 from last known exposure.

c. If any symptoms develop during this 14-day period, the exposed person must immediately isolate, get tested and contact their healthcare provider with any questions regarding their care.

**No** – You may come to school.
